DRAYAGE SERVICE INFORMATION

OUR COMPLETE SERVICE PACKAGE INCLUDES:

- Up to 10 day storage of display materials prior to event opening
- Delivery of materials from warehouse to your booth
- Removal and storage of crates and cartons during event
- Inbound shipping Labels

DRAYAGE SERVICE RATES:

EXPOSITIONS ETCETERA'S HANDLING FEES MUST BE PRE-PAID PRIOR TO SHOW OPENING. Fee listed for drayage services are handling fees only, for your convenience and do not include payment to the carrier for your shipment. You must pre-pay your carrier. Incoming shipments will not be accepted if not pre-paid to your carrier. For all outbound services we will ship your freight via ABF to you "freight collect". The carrier will request payment when freight is delivered to you unless third party billing has been established. Bill of ladings will be provided at the end of the show.

Rates listed below are for one-way handling (if ordering INBOUND AND OUTBOUND handling, figure fees based on weight for each shipment). Expositions Etcetera will weigh materials and charge accordingly if accurate weight is not provided.

First 100 lbs is \$ 65.00 per hundred weight up to 1000 lbs <u>AFTER</u> 1000 LBS is met, FREIGHT <u>ABOVE</u> 1000 LBS will be charged at .74 per pound, for example1200 lbs would be \$888.00. Rates are subject to change if union rates prevail. Drayage form must be filled out and returned to office <u>There is a minimum charge of \$25.00 for envelopes received</u>. Freight received without prior notice will have additional fees.

Additional charges will be incurred for special handling of equipment if necessary (forklift, added labor, shrink wrap, banding etc), at management's discretion with prevailing rates. Expositions Etcetera will be held harmless if materials will not fit through exiting doorways, elevators, etc.

<u>STORAGE</u>: There is an additional charge (minimum of \$500.00) if freight must be stored beyond the 20 days offered prior to show dates.
