## Manufacturers' Show Space Draw Rules & Regulations

- A drawing to allocate manufacturer's display space will be held in August each year. The order in which space is chosen is determined by previous year's drawing order. In order to maintain the same drawing order, manufacturers must return the RV SuperShow contract with a deposit by the specified deadline. Manufacturers submitting deposits after the specified deadline will not be guaranteed space but will be added to the end of the drawing order.
- If a manufacturer fails to return the contract with a deposit by the specified deadline, he will forfeit his previous year's drawing number and will go to the bottom of the drawing list. The only exception to this rule is when Show Management has had contact with a manufacturer and special arrangements have been made for the timely return of a deposit and contract.
- If a manufacturer creates a new product line and wants a separate display space, the new product will be added to the bottom of the drawing order based on when the contract and deposit for the new product was returned to the FRVTA State Office.
- If a manufacturer buys another manufacturing company or product line, the purchasing company will maintain the same drawing number provided they return the contract and deposit by the specified deadline. In the case where a manufacturer discontinues a product or product line, he can retain the same drawing number by submitting a contract for a new product or product line. You cannot substitute an existing product into an established drawing number.
- Each manufacturer will have the option of choosing any available space when their drawing number comes up. Inside exhibitors can only pick one block from the draw map. Outdoor exhibitors may pick up to two contiguous blocks to accommodate their square footage requirements.
- Manufacturers must specify their Florida dealer(s) that will work their display. Manufactures may designate in writing a dealer to select display space for them based on the drawing order established by these rules.
- If a manufacturer does not designate a dealer to select space for them and is unavailable to choose space when it is their time to draw, Show Management will draw space for them based on square footage they requested on the contract. It is not necessary for a manufacturer to be present at the drawing.
- Any manufacturer whose initial deposit check is returned for any reason will forfeit all rights to their drawing number and could be prohibited from displaying in any future FRVTA sponsored show. The manufacturer will be liable for all bank charges, collection fees and attorney fees incurred by FRVTA in pursuit of collection of the monies due.
- Manufacturers cannot have the same products for product lines in more than one display space. Manufacturers can appoint more than one dealer to work their display. Dealers will only be allowed to show the products that the manufacturer has assigned to them. Show Management has the right to remove all products not in compliance with the RV SuperShow contract and shut down the violating exhibit. There will be no subletting of display space.
- If, for any reason, a manufacturer is unable to attend the RV SuperShow and the space they drew is available, Show Management has the right to resell the display space. There are no refunds or rebates of any kind. Show Management will determine which manufacturer(s) have the right to buy vacant show space. The Grandfathered Drawing Order may only be maintain for one year.
- Manufacturers violating any of these rules or any of the Show Rules could lose their drawing order number and could be prohibited from displaying product in any FRVTA sponsored show.
- Show Management shall have full power to interpret and enforce all rules and regulations and the power to make amendments thereto, and to enact such further rules and regulations, as it shall consider necessary for the proper conduct of the FRVTA SuperShow.
