By applying for this Off-Premises Permit, I acknowledge that I understand the following:

- A records inspection may be conducted at the off-premises location. Access to vehicles being displayed for sale is required.
Indicia of ownership must be available for every vehicle displayed for sale and must be reassigned to the dealer applying for the off-premises permit.
Buyer's guides must be displayed on all vehicles being offered for sale. (Not applicable for Mobile Homes and Recreational Vehicles)
A sign clearly identifying the dealer must be displayed at the location.
The dealer's name and business address, as listed on the dealer's original license, must be prominently included in all advertisements associated with the sale.
A dealer representative must be available at the location during the off-premises sale and a designated representative must be available to the Department (during sale hours) via the telephone number indicated on this application.
If more than one dealer is participating in the off-premises sale, the inventory must be clearly separated.
Recreational vehicle dealers understand that the off-premise sales must be in compliance with section 320.3203(5) a, b, or c, Florida Statutes.

I understand that failure to comply with the requirements listed above may cause the Department to take action against my license.

RV dealers that participate in off-premise sales will be required to apply for an off-premises license and provide either:

***I. Within area of sales responsibility:***

A notarized affidavit, signed by the dealer applying for the off-premises license, stating that the sale will be held in the dealer's designated sales area.

***II.*** Dealers selling new RVs will not be allowed to sell outside their area of sales responsibility unless they provide one of the following:

***1. Outside area of sales Responsibility:***

A written agreement signed by the dealer, the manufacturer of the new RV's that will be sold at the off-premise sale site, and the dealer in whose designated area of sales responsibility the off-premise sale will occur in. The agreement must:

- a. Identify the RV line-make to be sold
- b. List the dates of the off-premise sale
- c. Affirmatively authorize the sale of the same RV line make.

***2. Open area of sales responsibility:***

A notarized affidavit stating that the sale is not in any other dealer's area of sales responsibility and is in conjunction with a public show.

***III. Used Units***

A notarized affidavit stating the dealer will use the off-premise sale for used RVs only.

***IV. More than 35 dealers in show:***

A notarized affidavit stating the off-premise sale is in conjunction with a public vehicle show in which more than 35 dealers are participating and the show is predominantly funded by manufacturers.

**“Public vehicle show”** means an event sponsored by an organization approved under s.501.(c)(6) of the Internal Revenue Code which has the purpose of promoting the welfare of the RV Industry and is located at a site that:

- a. Will be used to display and sell recreational vehicles
- b. Is not the location set forth on any dealer's license as its place of business
- c. Is not used for off-premise sales for more than 10 days in a calendar year
